may issue on any of the foregoing, and any and all right, title, interest, privileges, damages, settlements and proceeds under, relating to, or arising from the Patent/Design Assets, including, without limitation, any claim against third parties for past, present or future infringement or misappropriation of the Patent/Design Assets, all of which or the same to be held and enjoyed by the Assignee for its own use and benefit, and for the use and benefit of its successors and assigns, as fully and entirely as the same would have been held and enjoyed by the Assignor, who acknowledges the Assignee's beneficial and legal ownership in and to such Patent/Design Assets, had no assignment or transfer been made;
