ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, I, the undersigned Assignor, assigned, transferred and set over, and do hereby sell, assign, transfer and set over to Assignee, free and clear of all liens and encumbrances, the entire right, title and interest in said Patent and all subsequently filed utility applications, substitutions, divisionals, PCTs, continuations and continuations-in-part thereof, and all subsequent United States Letters Patents which may be granted thereon, all reissues, reexams, and extensions thereof, all priority rights under the International Convention for the Protection of Industrial Property for every member country, and all other patents and applications for patents (including related rights, such as earlier filed patent applications to which this Patent claims priority, all future utility-model registrations, inventor's certificates and the like) heretofore or hereafter filed in any foreign country to said invention, and all patents (including all extensions, renewals and reissues thereof) granted in any foreign countries to said invention; and

I HEREBY authorize and request the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to transfer, maintain and issue patents on applications as aforesaid, to transfer, maintain and issue all patents for said invention, to Assignee in accordance with the terms of this Assignment;

AND I HEREBY covenant that I, the undersigned Assignor, have the authority and right to convey the interest herein assigned, and that each represent and warrant that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY covenants that I, as an undersigned Assignor, will execute or procure any further necessary assurance of title to said Patent, and at any time, upon the request and at the expense of said Assignee, will execute and deliver any and all papers that may be necessary or desirable to perfect the title to said invention, the Patent, subsequent applications, or any Letters Patent which may be granted that claims priority thereto, hereinafter in said Assignee, its successors, assigns or other legal representatives;

AND I HEREBY further covenants and agrees that I, as an undersigned Assignor, without further compensation, will communicate to Assignee any facts known to me respecting said Patent, and upon the request and at the expense of Assignee, will testify in any legal proceeding, including any interference, sign all lawful papers, execute any utility, divisional, continuation, continuations-in-part, foreign, PCT or substitute applications for patents for said invention, or any part thereof, and for the reissue or reexamination of any Letters Patent to be granted hereafter, and will make all rightful oaths and generally do everything possible for procuring the same or for aiding Assignee to obtain and enforce proper patent protection for said invention in all countries, including the United States.


