

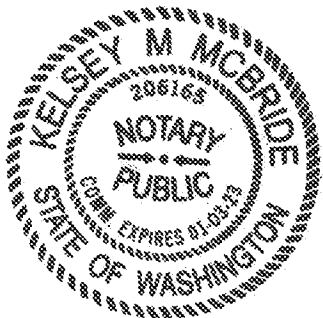



I. HEARING

- 1.1 Date: August 15th, 2018.
- 1.2 Purpose: To establish and probate May 14th, 2018, and to confirm the nonintervention powers of the named Personal Representative.
- 1.3 Appearances: Appearance on behalf of the petition was made by the attorney for petitioner.
- 1.4 Evidence: In addition to the verified petition, and the offered Will, testimony was given by affidavit and/or in open court which was reduced in writing and certified by the court.

II. FINDINGS

On the basis of the foregoing evidence the Court finds:

- 2.1 Jurisdiction: Decedent died on August 3rd, 2018, was a resident of King County at the time of his death and left property in the state of Washington subject to probate.
- 2.2 Competency: Decedent was legally competent to execute the offered Will on the date executed.

2 2.3 Execution: The offered Will was executed in the mode
3 prescribed by law and provides that the Personal
4 Representative may serve with nonintervention powers and
5 without bond.

6 2.4 Personal Representative: The person named in the Will as
7 Personal Representative is legally qualified to act as the
8 Personal Representative of the estate.

9 2.5 Solvency: The assets of the estate will exceed the
10 expenses, taxes, debts, and claims of creditors.

11 III. ORDER

12 On the basis of the Evidence and Findings, it is ORDERED:

13 3.1 Establishment: The offered Will is established as the last
14 Will of the decedent.

15 3.2 Probate: The established Will is admitted to probate.


16 3.3 Personal Representative. STEPHEN B. HULTBERG is confirmed
17 as Personal Representative and shall be issued letters
18 testamentary and/or a certification of qualification upon
19 filing an oath.

20 3.4 Solvency: The estate is solvent.

21 3.5 Nonintervention Powers: Upon filing an oath, the Personal
22 Representative may administer the estate without further
23 intervention of the court and without bond, and the
24 Personal Representative is authorized to transfer all
25 property of the estate without further order of the court.

26 3.6 Court Certificate: The affidavit on file was accepted as
27 proof of the Last Will and Testament admitted to probate.


