2. This Patent Assignment shall be construed, performed and enforced in accordance with, and governed by, the laws of the State of New Jersey, without giving effect to the principles of conflicts of laws thereof.

3. In the event that any provision of this Patent Assignment shall be construed to conflict with a provision of the Development Agreement, the provision in the Development Agreement shall be deemed controlling.

4. This Patent Assignment may be executed simultaneously in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

5. All capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Development Agreement.

6. Assignor hereby requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Patents.

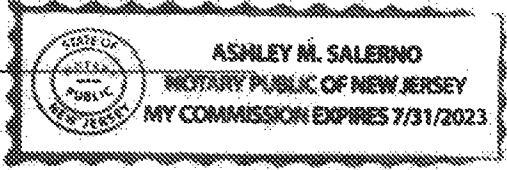
