ASSIGNMENT

WHEREAS, we,

We will, at any time upon the request and at the expense of the ASSIGNEE, execute and deliver any and all papers and do all lawful acts that may be necessary or desirable, in the opinion of the ASSIGNEE, to enable and assist the ASSIGNEE to (a) obtain patents, both domestic and foreign, on the Inventions, including without limitation execution of assignments of applications and priority rights and powers of attorney; (b) establish, maintain and secure title in the

ASSIGNEE, its successors and assigns, to the Inventions, Applications, and Patents, including making such title of lawful public record; and (c) defend, establish or otherwise preserve the validity of the Patents against any and all infringers, and perform such other acts as are necessary to give full force and effect to the foregoing assignment.

We represent and covenant that no assignment, mortgage, sale, license, pledge, encumbrance or alienation of the Inventions, the Applications, the Patents, or any other right assigned hereunder, has been or will be made or entered into which would conflict with the assignment thereof to ASSIGNEE.

We hereby authorize and request the Director of the United States Patent and Trademark Office to issue all patents based on the Applications and each division, continuation, substitution, reissue, renewal and extension thereof to the ASSIGNEE, its successors and assigns, or their respective designees.
