therefor and thereon (collectively, "Letters Patent"), and in and to any and all provisional and non-provisional patent applications that claim priority to said Letters Patent, and in and to any and all direct or indirect divisions, continuations, and continuations-in-part of said Letters Patent, rights of priority, post-grant certificates, other rights from administrative proceedings, or reissues or extensions of said Letters Patent, or equivalents or counterparts of any of the foregoing, and any other indicia of ownership issued or granted by any governmental body, and all rights under the International Convention for the Protection of Industrial Property, the same to be held and enjoyed by the said Assignee, for its own use and benefit and the use and benefit of its successors, legal representatives and assigns, to the full end of the term or terms for which Letters Patent may be granted or extended, as fully and entirely as the same would have been held and enjoyed by the Assignors, had this sale and assignment not been made, and all rights, with respect to any of the foregoing, to remedies and entitlements, including, income, royalties, damages and payments, due or payable before this Assignment or thereafter, including damages, injunctive relief, and payments for past, present or future infringements or misappropriations thereof, and the right to sue and recover for past, present, and future infringements or misappropriations thereof.

Inventions and Application for Letters Patent above-mentioned, and that the same are unencumbered and that each Assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth.

AND for the same consideration, Assignors hereby covenant and agree to and with Assignee, its successors, legal representatives and assigns, that Assignors will sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of any Letters Patent and applications for Letters Patent for said Inventions, without cost to Assignee, its successors, legal representatives and assigns, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns, shall advise: that any proceeding in connection with said Inventions, or said applications for Letters Patent, or any proceeding in connection with any Letters Patent or applications for Letters Patent for said Inventions in any country, including but not limited to interference or derivation proceedings, is lawful and desirable; or, that any division, continuation or continuation-in-part of any application for Letters Patent, or any reissue, reexamination, other administrative proceedings or extension of any Letters Patent, to be obtained thereon, is lawful and desirable.




