## TERMINATION AND RELEASE OF SECURITY INTEREST

This **TERMINATION AND RELEASE OF SECURITY INTEREST**, dated as of   October, 11th  , 2021 (this "Release"), is granted by **SILICON VALLEY BANK**, California corporation, with a loan production office located at 275 Grove Street, Suite 2-200, Newton, Massachusetts 02466 ("Bank") and **GUARDICORE LTD**, a company organized under the laws of the State of Israel, with its principal place of business located at 23 Derech Menachem begin, 23rd Floor, Tel Aviv, Israel 6618356 ("Grantor") (collectively, the "Parties" and each individually, a "Party").

A. **WHEREAS**, the Parties and **GUARDICORE, INC.**, a Delaware corporation ("US Borrower") (Grantor and US Borrower are hereinafter jointly and severally, individually and collectively, referred to as "Borrower") entered into the Loan and Security Agreement, dated as of January 14, 2019 (as may be amended, modified or supplemented from time to time, the "Loan Agreement");

B. **WHEREAS**, pursuant to the Loan Agreement, the Grantor and the Bank entered into the Intellectual Property Security Agreement, also dated as of January 14, 2019, (as amended, supplemented, restated or otherwise modified from time to time, the "Intellectual Property Security Agreement"), which granted the Bank a security interest in all right, title and interest in the Copyrights, Trademarks, Patents, and Mask Works scheduled at Exhibits A-D (collectively, the "Secured Intellectual Property") to secure the obligations of Borrower to Bank;

C. **WHEREAS**, the Intellectual Property Security Agreement was recorded with the U.S. Patent and Trademark Office ("USPTO") at Reel / Frame 047989/0806 on January 14, 2019;

D. **WHEREAS**, the Borrower has requested that the Bank enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Bank may have had in the Secured Intellectual Property pursuant to the Intellectual Property Security Agreement and Loan Agreement.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the Bank and the Grantor agree as follows:

1. **Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Loan Agreement or Intellectual Property Security Agreement, as applicable.

2. **Termination and Release.** The Bank hereby absolutely, unconditionally and irrevocably (a) terminates, cancels, discharges, relinquishes and releases the Intellectual Property Security Agreement granted pursuant to the Loan Agreement; and (b) terminates, releases, and discharges any and all of the Bank's right, title and interest in, to and under the Secured Intellectual Property. The Bank authorizes and requests the recordation of this Release against the Secured Intellectual Property with the USPTO and any other applicable governmental authority.

3. **Further Assurances.** At the request and sole expense of the Borrower, the Bank agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary or reasonably requested by the Borrower to carry out the purposes of this Release.

4. **Choice of Law.** This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the

transactions contemplated hereby shall be construed in accordance with and governed by the laws of the State of Massachusetts without regard to any conflict of laws principles thereof that would call for the application of the laws of any other jurisdiction..

5. **Miscellaneous.** This Release may not be supplemented, altered or modified in any manner except by a writing signed by all parties hereto. This Release shall be binding upon the Bank's representatives, successors, assigns and transferees and is made in favor of and for the benefit of the Grantor and its successors and assigns. This Release may be executed in counterparts, each of which shall be deemed an original, but all of which together constitute one and the same original. Unless this Release states otherwise, any reference to "any" shall mean "any and all" and "or" is used in the inclusive sense of "and/or".


