AND, WE HEREBY further covenant and agree that we will, without further consideration, communicate with the Assignee, its successors and assigns, any facts known to us respecting this invention, and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title to this invention in the Assignee, its successors or assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths and generally do everything possible to aid the Assignee, its successors and assigns, to obtain and enforce proper patent protection for this invention in Australia and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by the Assignee, its successors and assigns.
5. Any stamp duty payable on this Deed will be paid by the Assignee.
6. This Deed may be executed in counterparts. All counterparts taken together will be taken to constitute one instrument.
7. This Deed is governed by and is to be construed in accordance with the laws of Queensland, Australia.




