## NOTICE OF GRANT OF SECURITY INTEREST

Dated: October 1, 2021

United States Patent and Trademark Office

Ladies and Gentlemen:

Please be advised that pursuant to that certain Loan and Security Agreement, dated as of November 2, 2018 (as the same be amended, restated, amended and restated, supplemented, extended or otherwise modified from time to time, the "Loan Agreement"), by and among MUNICIPAL PARKING SERVICES, INC., a Minnesota corporation ("MPS"), the Lenders (as defined therein) from time to time party thereto, and TONKAWA, INC., as administrative agent and collateral agent for the Lenders (in such capacity, together with its successors and assigns in such capacity, "Administrative Agent"), MPS has granted to the Administrative Agent a continuing first priority security interest in and continuing lien upon, among other things: (a) the trademark registrations and applications set forth on Exhibit A hereto, together with the associated goodwill, and all extensions and renewals thereof, and excluding only U.S. intent-to-use trademark applications to the extent that, and solely during the period in which, the grant, attachment, or enforcement of a security interest therein would, under applicable federal law, impair the registrability of such applications or the validity or enforceability of registrations issuing from such applications; (b) and the patents and patent applications set forth on Exhibit B hereto and all reissues, divisions, continuations, continuations-in-part, renewals, extensions, and reexaminations thereof and amendments thereto. Capitalized terms used herein but not defined herein shall have the meanings given in the Loan Agreement.

MPS and the Administrative Agent hereby acknowledge and agree that the security interest in the foregoing trademark registrations, trademark applications, patents and patent applications (i) may only be terminated in accordance with the terms of the Loan Agreement, and (ii) is not to be construed as an assignment of any Trademark or Patent. MPS and the Administrative Agent hereby further acknowledge and agree that the Loan Agreement shall supersede and control over any conflicting or inconsistent provision herein, and that the rights and remedies of the Administrative Agent with respect to the Trademarks and Patents are as provided by the Loan Agreement and related documents, and nothing in this Notice of Grant of Security Interest shall be deemed to limit such rights or remedies. MPS authorizes the Commissioner for Patents, the Commissioner for Trademarks, and any other government officials to record and register this Notice of Grant of Security Interest upon request by the Administrative Agent.
