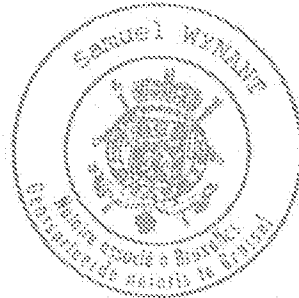
The undersigned, **Samuel WYNANT**, notary public at 'Van Halteren Notaires Associés', in Brussels (Belgium), hereby certify that the private limited liability company (SPRL) **UCB BIOPHARMA**, RPM/RPR 0543.573.053, having its registered office at Anderlecht (1070 Brussels), Allée de la Recherche 60, has implemented the new Belgian Code of Companies and Associations on December 2, 2019.

This new Belgian Code of Companies and Associations mandatory changed the name of the legal form "société privée à responsabilité limitée/ besloten vennootschap met beperkte aansprakelijkheid" to "société à responsabilité limitée / besloten vennootschap", and the respective abbreviations "SPRL" and "BVBA" are mandatory and automatically changed to "SRL" and "BV" respectively.

As a consequence, the name of the legal form of the entity UCB Biopharma has changed into "**société à responsabilité limitée**", abbreviated "**SRL**". This change of name of the legal form of the entity **UCB BIOPHARMA** has no other legal consequences. The company name, company number and VAT No. (BE 0543 573 053) and registered office of UCB BIOPHARMA remain the same.
