1. Constituent Entities.

An Agreement and Plan of Merger (the "**Merger Agreement**") has been authorized, approved and adopted pursuant to (i) the operating agreement of the LLC, (ii) the organizational documents of the Corporation, (iii) the Act and (iv) the Delaware General Corporation Law ("**DGCL**"). A copy of the Merger Agreement shall be kept on file at the office of the Corporation set forth in Section 1 and furnished, upon request without cost, to any member of the LLC or to any person holding an interest in the Corporation.

3. Surviving Entity. The surviving entity shall be the Corporation, which shall continue in existence as the Surviving Entity under its present name upon the effective date of this merger pursuant to the provisions of the Act and the DGCL.

4. Agent of Service. The Corporation hereby irrevocably appoints the Secretary of the Commonwealth of Massachusetts to be its true and lawful attorney upon whom all lawful process in any action or proceeding in the Commonwealth of Massachusetts may be served in the manner set forth in Section 15.10 of Chapter 156D of the Massachusetts General Laws

5. Effective Time. The merger is to become effective on June 15, 2020.

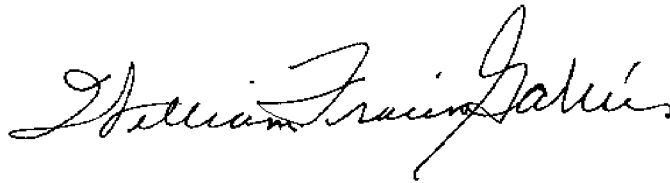
