ASSIGNMENT

WHEREAS, Eric W. Monda of 9338 Cornell Circle, Highlands Ranch, Colorado 80130, and Bernard F. Kutter of 801 Brown Squirrel Lane, Golden, Colorado 80401, have invented a certain new and useful invention entitled "ORBITAL RENDEZVOUS TECHNIQUES" (hereinafter "Invention") for which an application for Letters Patent of the United States has been prepared and filed on May 1, 2019, receiving Serial No. 16/400,383, and further identified as Attorney File No. 5704-109 (hereinafter "Application").

Kutter, one of the said inventors, for and in consideration of certain good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, at the request of ASSIGNEE, does sell, assign and transfer unto ASSIGNEE, its successors, legal representatives and assigns, the Invention for all territories in the world and any improvements and modifications thereto, the Application, all applications from which the Application claims the benefit of priority, all applications claiming the benefit of priority from the Application, including, but not limited to, all continuation, divisional, continuation-in-part and reissue applications, all patent applications in foreign countries, all applications pursuant to the Patent Cooperation Treaty and all applications for extension filed or to be filed for the invention, and all Letters Patent, Invention Registrations, Utility Models, Extensions or Reissues and other patent rights, obtained for the Invention in the United States or any other country and the right to sue for past infringement of rights resulting from the Invention, the Application or any patent issuing therefrom; the Estate of Bernard F. Kutter also assigns any right, title or interest in and to the Invention which has not already been transferred to ASSIGNEE, and warrants that neither the Estate of Bernard F. Kutter nor Bernard F. Kutter have made an assignment of the Invention, Application or patent therefor to a party other than ASSIGNEE, and the Estate of Bernard F. Kutter is under no obligation to make any assignment of the Invention, Application, or patent therefor to any other party; and the Estate of Bernard F. Kutter further agrees to cooperate with ASSIGNEE in the obtaining and sustaining of any and all such Letters Patent and in confirming ASSIGNEE'S exclusive ownership of the Invention, but at the expense of ASSIGNEE.

For and in consideration of certain good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the Estate of Bernard F. Kutter does sell, assign and transfer to ASSIGNEE, the right to claim priority to the Application for all applications pursuant to the Patent Cooperation Treaty and national and regional applications filed therefrom, all applications for the territory of the United States of America and all continuation, divisional,


continuation-in-part and reissue applications thereof, and all patent applications in foreign countries and the right to be granted a patent for any of the foregoing applications.

The Commissioner of Patents is hereby authorized and requested to issue the Letters Patent solely in accordance with the terms of this Assignment, to ASSIGNEE, its successors, legal representatives and assigns, as an assignee of an equal, undivided right, title and interest therein.
