CERTIFICATE DATED 19TH OCTOBER, 2021

The undersigned, **Me Léonie GRETHEN**, notary residing in Esch-sur-Alzette, duly appointed in the Grand Duchy of Luxembourg, hereby attests and certifies what follows:

- I. That on the 17th September 2021, an extraordinary general Meeting of the Shareholders of **ROTAREX S.A.**, a public limited company established under the laws of the Grand-Duchy of Luxembourg, having its registered office at 24, rue de Diekirch, L-7440 Lintgen, Grand-Duchy of Luxembourg, and registered with the *Registre de Commerce et des Sociétés* under number B 30984 has been held in my Ministry enacting the approval of the merger proposal between **ROTAREX S.A.** (the **Absorbing Company**) and **LUXEMBOURG PATENT COMPANY S.A.**, a public limited company established under the laws of the Grand-Duchy of Luxembourg, having its registered office at 24, rue de Diekirch, L-7440 Lintgen, Grand-Duchy of Luxembourg, and registered with the *Registre de Commerce et des Sociétés* under number B 41581 (the **Absorbed Company**) by way of absorption (the **Merger**) which Merger Proposal has been published in the *Recueil Electronique des Sociétés et Associations (RESA)* on 23rd July 2021 under reference RESA_2021_157.816.
- II. That following the deed signed in my Ministry on 17 September 2021 and published in the RESA on 23rd September 2021 under reference RESA_2021_203.307, the Absorbing Company is the owner of all the shares representing the entire share capital and all voting rights of the Absorbed Company, the Merger is subject to the specific provisions of article 1023-1 of the law of August 10, 1915, on commercial companies, as amended (the Law).
 - i. The Merger has become effective on 17 September 2021 and has become effective vis-à-vis third parties at the date of the publication of the said deed approving the merger proposal on 23rd September 2021 having the following consequences ipso jure on the Effective Date:
 - ii. the universal transfer, both between the Absorbed Company and the Absorbing Company and towards third parties, of all of the assets and liabilities of the Absorbed Company to the Absorbing Company;
 - iii. the cessation of the Absorbed Company, which is dissolved without liquidation;
 - iv. the cancellation of all the shares of the Absorbed Company; and
 - v. all other consequences, as listed in the Merger Proposal.
