U.S. PATENTS

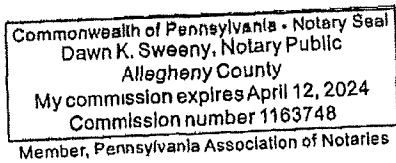
