

AND ASSIGNOR DOES HEREBY covenant and agree that ASSIGNOR will communicate to said ASSIGNEE, its successors, legal representatives and assigns, any facts known to ASSIGNOR respecting the Work, and testify in any legal proceeding, assist in the preparation of any other provisional or non-provisional applications relating to the Application and the Work or any improvements made thereto, sign all lawful papers, authorize the filing of and execute and make all rightful oaths and/or declarations in connection with the Application and the Work including any improvements made thereto, any patent applications filed therefrom, and any continuing application filed from any of the aforementioned applications, and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the Work in all countries. If ASSIGNOR is requested by the owner of the rights conveyed hereby to take action under this paragraph the owner shall reimburse ASSIGNOR for reasonable out-of-pocket expenses actually paid by ASSIGNOR and incurred and paid as a result of complying with the owner's request; provided that receipts showing the amount actually paid are submitted to such owner.






