RELEASE OF SECURITY INTEREST IN PATENTS

This Release of Security Interest in Patents, dated as of October 29, 2021 (this “**Patent Release**”) is executed and delivered by Alter Domus (US) LLC, as administrative agent (the “**Agent**”), under the Notice of Grant of Security Interest in Patents, dated as of October 26, 2020 (the “**Patent Grant**”) made by Rent the Runway, Inc. (the “**Grantor**”) in favor of the Agent and recorded October 27, 2020 in the records of the United States Patent and Trademark Office at Patent Reel 54175, Frame 144.

WHEREAS, the Grantor has entered into that certain Security Agreement, dated as of October 26, 2020 (as amended, restated, supplemented, modified or otherwise changed from time to time, the “**Security Agreement**”), in favor of the Agent; and

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Agent a continuing security interest in all right, title and interest of the Grantor in, to and under the Patent Collateral as defined in the Patent Grant (the “**Released Patent Collateral**”);

WHEREAS, the Agent now wishes to release and terminate its security interest in the Released Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Unless otherwise defined herein, any capitalized term used herein shall have the meaning given to it in the Patent Grant.
2. The Agent hereby terminates and cancels the Patent Grant, and terminates, cancels, releases and discharges all of its security interest in all of the Grantor’s right, title and interest in and to the Released Patent Collateral, including, without limitation, the patents and patent applications listed on Schedule I attached hereto, and all rights to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof and all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto.
3. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents as may be reasonably necessary to effect, record or evidence more fully the purposes of this Patent Release.
4. The Agent authorizes and requests that the Commissioner of Patents of the United States Patent and Trademark Office record this Patent Release.
