**RELEASE AND TERMINATION
OF SECURITY INTEREST IN PATENT COLLATERAL**

THIS RELEASE AND TERMINATION OF SECURITY INTEREST IN PATENT COLLATERAL, dated as of September 30, 2021 (this “Release”), is made by GLAS TRUST CORPORATION LIMITED, in its capacity as Security Agent (the “Assignee”) under that certain Patent Security Agreement, dated as of September 28, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Patent Security Agreement”), among B&G EQUIPMENT COMPANY, INC. and CURTIS DYNA-FOG, LTD. (the “Grantors”) and the Assignee. Capitalized terms used herein without definition are used as defined in the Patent Security Agreement.

WHEREAS, pursuant to the Patent Security Agreement which was recorded in the records of the United States Patent and Trademark Office on October 11, 2018 at reel 047136, frame 0891, the Grantors granted to the Assignee on behalf of the Lenders a Lien on and a security interest in and to, all of the Grantors’ right, title and interest in, to and under their owned or thereafter acquired Patents, including those Patents set forth on the attached Schedule A, and all other Patent Collateral;

WHEREAS, pursuant to that certain Payoff Letter and Deed of Release of Security, each dated as of September 30, 2021, by and among the Grantors, the other signatories party thereto and the Assignee, the Grantors have requested that the Assignee, and the Assignee has agreed to, (a) release any and all security interests it may have in the Patents and other Patent Collateral pursuant to the Patent Security Agreement and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Patents and other Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the Liens and security interest created under the Patent Security Agreement in the Patents and other Patent Collateral, (b) release and relinquish its security interest in the Patents and other Patent Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Assignee in the Patents and other Patent Collateral. The Assignee agrees, or authorizes the Grantors, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantors to evidence the release and termination of the Assignee’s security interests in the Patents and other Patent Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
