I further agree that all obligations hereunder shall survive any termination of my employment and

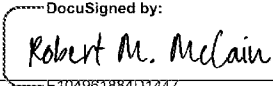

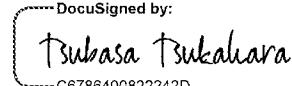
