Pursuant to Title 8, Section 264(c) of the General Corporation Law of the State of Delaware, as amended (the "DGCL"), Tank Holding Corp., a Delaware corporation (the "Company"), in connection with the merger of Norwesco, LLC, a Minnesota limited liability company ("Norwesco"), with and into the Company (the "Merger"), hereby certifies as follows:

FIRST: The names and states of incorporation of the constituent entities to the Merger (the "Constituent Entities") are:

SECOND: An Agreement and Plan of Merger, dated as of December 23, 2020 (the "Plan of Merger"), by and between the Company and Norwesco, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Entities in accordance with Sections 228 and 264(c) of the DGCL and Chapter 322C, Section 1002 of the Minnesota Statutes.

THIRD: Upon the effectiveness of the Merger, the Company shall be the surviving corporation (the "Surviving Entity"), and the name of the Surviving Entity shall be "Tank Holding Corp."

FOURTH: The certificate of incorporation of the Company, as in effect immediately prior to the effectiveness of the Merger, shall remain unchanged, and shall be the certificate of incorporation of the Surviving Corporation.

FIFTH: The Merger shall become effective on December 31, 2020 at 11:59 p.m. EST.


