Assignee hereby indemnifies and otherwise holds Assignor and its affiliated companies harmless from and against any and all damages, claims, demands, liabilities or expenses (including reasonable outside attorney's fees) which Assignor may suffer or incur arising out of or resulting from Assignee's exercise of the rights granted hereunder, including, without limitation, the use and exploitation by Assignee, its licensees or assigns, of the Patents.
4. The parties hereto hereby agree to sign and/or deliver to each other such further instruments as may be reasonably required to carry out the intent of this Agreement.
