PATENT ASSIGNMENT

This PATENT ASSIGNMENT ("Agreement") is entered into by and between David B. Higgins does hereby transfer, sell, and assign to ING Source, its successors, assigns, and nominees, as the assignee, *nunc pro tunc* effective August 1, 2016, without any restrictions, reservations, or limitations, the entire and exclusive right, title, and interest in and to the Patent including (a) the sole right to enforce the Patent with the right to sue for and recover accrued profits or damages for any and all infringements thereof, including, but not limited to, past infringements, and (b) any and all other legal claims or causes of action relating to the Patent.
