ARTICLES OF DOMESTICATION
OF

The undersigned, on behalf of the foreign limited liability company set forth below, pursuant to Title 13.1, Chapter 12, Article 14 of the Code of Virginia, states as follows:

1. **Name.** The name of the foreign limited liability company immediately before the filing of these articles of domestication is Maniff Creations, LLC. Upon the filing of these articles, the name of the limited liability company shall be **Maniff Creations, LLC.**
2. **Organization Date.** The limited liability company was originally incorporated under the laws of California on May 6, 2019 as a General Stock Corporation with the name Maniff Creations, Inc. The company was then converted under the laws of California on February 18, 2021 to a Limited Liability Company with the name Maniff Creations, LLC.
3. **Plan of Domestication.** The plan of domestication, pursuant to § 13.1-1075 of the Code of Virginia, is set forth as follows:
 - A. The limited liability company is presently domesticated under the laws of California, and the jurisdiction in which the limited liability company is to be domesticated is the Commonwealth of Virginia.
 - B. The full text of the amended and restated articles of organization of the limited liability company that will be in effect upon consummation of the domestication is attached hereto.
4. **Permitted by Law.** The domestication is permitted by the laws of the jurisdiction in which the limited liability company is organized immediately before the filing of these articles, and the limited liability company has complied with those laws in effecting the domestication.

The undersigned, pursuant to Chapter 12 of Title 13.1 of the Code of Virginia, states as follows:

1. **Name.** The name of the limited liability company is **Maniff Creations, LLC.**
