

ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been made or entered into with any party other than ASSIGNEE which would conflict with this Assignment.

ASSIGNORS further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said inventions and said patent application and legal equivalents as may be known and accessible to ASSIGNORS and will testify as to the same in any interference, litigation or proceeding related thereto and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce any patents thereof which may be necessary or desirable to carry out the purposes thereof.

This grant specifically includes, without limitation, the right to recover for any third-party infringement thereof, regardless of whether such infringement occurred before or occurs after the effective date of this Assignment.

This Assignment may be executed in several counterparts, each of which shall constitute an original and all of which, when taken together, shall constitute one agreement. Executed signature pages to this Assignment may be delivered by facsimile, or by scanned email copy and delivery of the Assignment containing the signature page by facsimile or email will have the same effect as if the Assignment containing an original signature had been delivered from the sending party to the receiving party.
