Assignor does hereby sell, assign, convey and transfer to Assignee all of Assignor’s right, title and interest in and to the Assigned Patent, including, without limitation: the right to make, to use, to sell and to offer for sale the inventions of the Assigned Patent; any divisions, continuations, continuations-in-part, renewals and foreign counterparts thereof; all rights to apply for registration in foreign countries with full benefit of such priority as may now or hereafter be granted to it by law, treaty or other international convention; all rights, interests, claims and demands recoverable in law or equity that Assignor has or may have in profits and damages for past, present and future infringements of the Assigned Patent, including, without limitation, the right to compromise, sue for and collect such profits and damages; all of the foregoing to be held and enjoyed by Assignee, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.


