Second Lien Release of Security Interest in Patents

This Second Lien Release of Security Interest in Patents, dated as of November 21, 2021 (the "Release"), is made by AEA DEBT MANAGEMENT LP, as collateral agent (in such capacity, the "Agent") in favor of 128 COMBUSTION INC., a Delaware corporation (the "Grantor").

WHEREAS, by (i) that certain Second Lien Security Agreement, dated as of October 26, 2018 in favor of Agent (as amended, restated, or modified from time to time, the "Security Agreement") and (ii) that certain related second lien Grant of Security Interest in Patent Rights, dated as of December 2, 2019 in favor of Agent (as amended, restated, or modified from time to time, the "Patent Security Agreement"; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Patent Security Agreement, as applicable), the Grantors granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantors' right, title and interest in, to and under the Collateral (as defined in the Patent Security Agreement), including those Patents listed on Schedule I hereto;

WHEREAS, the Grantors desire Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral of the Grantors (as defined in the Patent Security Agreement), including, without limitation, the Patents set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral of the Grantors (as defined in the Patent Security Agreement) and assigns, transfers and conveys to Grantors any and all of its rights, title and interests in the Collateral.

The Agent, without representation or warranty of any kind, terminates and cancels the Patent Security Agreement.

The Agent authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release.

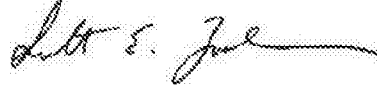
