Hereinafter referred to as Assignor, have made the invention having the title:



**"METHOD AND DEVICE FOR SUPPLYING COOL FLUID"**

The terms of this Deed of Assignment prevail over any other assignment or other deed, if any previously made in respect of the same matters.
