PATENT ASSIGNMENT

This PATENT ASSIGNMENT, effective as of November 26 2021 (the "Effective Date"), is by and between PECW HOLDING COMPANY, a Wisconsin corporation, having a principal place of business at 3518 Lakeshore Road, Sheboygan, WI, 53083 ("Assignor"), and PLASTICS ENGINEERING COMPANY, a Wisconsin corporation, having a principal place of business at ~~1720 North Avenue~~, Sheboygan, WI, 53083 ("Assignee") (each a "Party" and, collectively, the "Parties").

WHEREAS, Pursuant to the Agreement, Assignor has agreed to execute and deliver this Patent Assignment, for recording with governmental authorities including, but not limited to, the U.S. Patent and Trademark Office and other applicable governmental patent offices in various countries around the world.

NOW, THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor hereby irrevocably conveys, transfers and assigns to Assignee, and Assignee hereby accepts, all of Assignor's all right, title, and interest Assignor holds in: (i) the patents and patent applications set forth in Schedule A hereto, any and all additional patent applications (provisional and non-provisional, utility, and otherwise), and all continuations, divisionals, continuations-in-part, utility models, reissues, reexaminations, extensions, validations, renewals, substitutes, and foreign counterparts thereof, and all other similar rights which may be granted thereon (hereinafter, "Patents"); (ii) any and all past, present, and future causes of action, rights and remedies arising under each of the foregoing, including the right to sue for, and recover for, past infringements of, damages under, and liabilities for each of the foregoing; and (iii) the sole right to proceed as applicant or patent owner under the Patents, and the rights set forth in subparts (i) and (ii), in all countries, including all rights of priority in said countries under the laws and rules of the EPO, the United States, the Paris Convention, and the terms of any other applicable law, international convention, or treaty.

2. Successors and Assigns. The terms and provisions of this Patent Assignment shall inure to the benefit of Assignee and its successors and assigns, and shall be binding on Assignor and its legal representatives and any corporation controlling Assignor.

3. Terms of the Contribution Agreement. The Parties hereto acknowledge and agree that the representations, warranties, covenants and agreements contained in the Contribution Agreement shall not be superseded, enlarged, limited or otherwise modified hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms

of the Contribution Agreement and the terms hereof, the terms of the Contribution Agreement shall govern.

4. Further Actions. The Assignor further agrees to provide to the Assignee and its successors, assigns or other legal representatives, all such cooperation and assistance (including without limitation to execute any other documents) and take any further action that the Assignee may reasonably request to effect the intent and purpose of this assignment; provided, that the cost and expense of such documents and actions shall be borne solely by the Assignee.

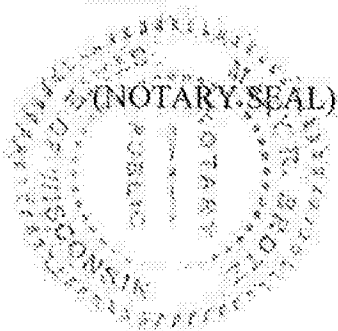
