PATENT APPLICATION ASSIGNMENT

Assignor hereby, absolutely and unconditionally, conveys, sells, assigns, transfers, grants and sets over unto the Assignee, all of the Assignor's right, title and interest and benefit in and to the Assigned Intellectual Property owned by the Assignor as of the Effective Time, together with all rights of action, both at law and in equity with respect thereto, including all rights to sue, settle any claim, and collect all damages and lost profits for any past, present, or future infringement of the Assigned Intellectual Property, the same to be held and enjoyed by the Assignee, its successors and assigns forever, as fully and entirely as the same could have been held and enjoyed by the Assignor if this sale had not been made and the Assignee does hereby accept such sale, assignment, transfer, grant, conveyance and set over.




