RECITALS

- A. The Assignor is represented by a liquidator, with Securicom (NSW) Pty Ltd , the registered owner of the patent rights set out in the Schedule to this Deed (the IP Rights), having been wound up pursuant to Section 436C(c) of the Australian Corporations Act 2001.
- B. The Assignor and Assignee acknowledge that, subject to a Deed of Assignment dated 31 July 2019 between the Assignor and Assignee, the Assignor has assigned the Assignee all the Assignor's right, title and interest in and to the IP Rights, including the right to apply for intellectual property rights in any country or region worldwide (the Territory).
- C. The parties wish to confirm the assignment of all the Assignor's right, title and interest in and to the IP Rights to the Assignee on the terms of this Deed.

OPERATIVE PROVISIONS

- (1) In consideration good and valuable consideration paid on behalf of the Assignee to the Assignor, the receipt of which is acknowledged, the parties confirm that the Assignor has assigned to the Assignee, and the Assignee has accepted absolutely:
 - (a) the entire right, title and interest in and to the IP Rights;
 - (b) all rights arising from the Inventions in the Territory, including the benefit of all priority rights;
 - (c) all rights to file in the Territory further patent applications (as applicable) and applications to register intellectual property rights in connection with the IP Rights; and
 - (d) all rights, powers, liberties and immunities arising from any statutory rights granted in relation to the IP Rights, including the right to sue for and obtain injunctive relief, damages and all other remedies in respect of any infringement of the statutory rights which may have occurred prior to the date of assignment.

- (2) To the extent that any rights in the IP Rights are not effectively assigned by the Assignor to the Assignee subject to clause 1, the Assignor hereby assigns, for good and valuable consideration receipt of which is acknowledged, any such intellectual property to the Assignee, which the Assignee has accepted absolutely, such that the Assignee is assigned:
- (a) the entire right, title and interest in and to the IP Rights;
 - (b) all rights arising from the Inventions in the Territory, including the benefit of all priority rights;
 - (c) all rights to file in the Territory further patent applications (as applicable) and applications to register intellectual property rights in connection with the IP Rights; and
 - (d) all rights, powers, liberties and immunities arising from any statutory rights granted in relation to the IP Rights, including the right to sue for and obtain injunctive relief, damages and all other remedies in respect of any infringement of the statutory rights which may have occurred prior to the date of assignment.
- (3) This Deed is governed by and must be construed in accordance with the laws of New South Wales, Australia.






