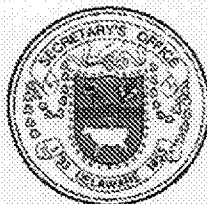

AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF  
VISIONARY VR, INC.

Visionary VR, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "*Company*"), does hereby certify as follows:

1. The name of the Company is Visionary VR, Inc. The Company's original Certificate of Incorporation was first filed with the Secretary of State of the State of Delaware on September 5, 2014 under the name Visionary VR, Inc.

2. The Company's Amended and Restated Certificate of Incorporation (the "*Restated Certificate*"), is hereby amended by replacing Article I. thereof with the following new Article I:


"I. The name of this corporation is Mindshow Inc. (the "*Company*")."

3. All other provisions of the Restated Certificate shall remain in full force and effect.
