(c) all causes of action (whether known or unknown or whether currently pending, filed or otherwise) and other enforcement rights under or on account of the Listed Patents, including without limitation all causes of action and other enforcement rights for damages, injunctive relief, and any other remedies of any kind for past, current and future infringement; and

(d) all rights to collect royalties or other payments under or on account of the Assigned Patents and the foregoing subcategory (c). (subcategories (a), (b), (c), and (d) collectively, the "Assigned Patent Rights").

Seller agrees upon request (and at the expense) of Buyer to, and if Seller is unable or unwilling to do so authorizes Buyer to act in Seller's name to: execute all oaths, assignments, powers, and any other papers necessary to perform Seller's obligations hereunder, testify in any proceeding, and otherwise take any action, and fully cooperate with Buyer to perform Seller's obligations hereunder, in each case, related to securing and enforcing Buyer's rights related to this Assignment.

For good and valuable consideration, the receipt of which is hereby acknowledged, Pfeffer hereby irrevocably assigns, sells, grants, transfers, and conveys to Buyer, and Buyer hereby accepts and receives, all of Pfeffer's right, title, and interest throughout the world in and to the Listed Patents, the Assigned Patents, and the Assigned Patent Rights, solely to the extent Pfeffer has any such right, title, or interest.

The terms and conditions of this Assignment will inure to the benefit of Buyer, its successors, assigns, and other legal representatives and will be binding upon Seller, its successors, assigns, and other legal representatives.

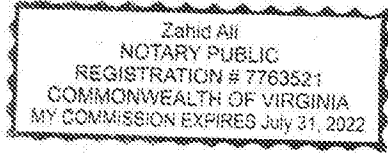

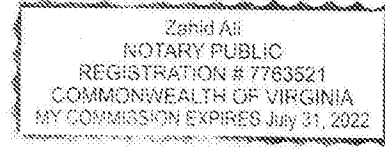
