WHEREAS, Atlassian Pty Ltd., having its principal place of business at 341 George Street, Sydney, Australia and Atlassian Inc., having its principal place of business at 350 Bush Street, San Francisco, California 94104 (hereinafter, individually and collectively the "Assignees"), desire to acquire any and all, right, title, and interest of Assignor in and to the invention(s), the Patent Rights, and in, to, and under any and all Letters Patent to be obtained therefor (the "Assigned Rights"), the Assigned Rights to be co-owned by the Assignees in accordance with an ownership percentage determined by the Assignees;

UPON SAID CONSIDERATION, the Assignor hereby covenants and agrees with the Assignees that it will not execute any writing or do any act whatsoever conflicting with these presents, and that it will, at any time upon request, without further or additional consideration, but at the expense of the Assignees, execute such additional assignments and other writings and do such additional acts as Assignees may deem necessary or desirable to perfect the Assignees' enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, provisionals, non-provisionals, continuations, continuations-in-part, continuing prosecutions, divisionals, renewals, reissues, reexamined or extended Letters Patent of the United States, or of any and all foreign countries, on said Patent Rights, and execute confirmatory assignments or acknowledgments of this assignment as necessary for full enjoyment of the Patent Rights and for recording in foreign patent offices, and in enforcing any rights or choses in action accruing as a result of such Patent Rights, by giving testimony in any proceedings or transactions involving such Patent Rights, and by executing preliminary

statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties;

UPON SAID CONSIDERATION, Assignor represents and warrants that Assignor has the right, title, and authority to execute this Assignment and to convey any and all right, title, and interest in the Patent Rights, and that Assignor has not conveyed nor will convey hereafter all or part of the Patent Rights to a third party;

ASSIGNOR HEREBY AUTHORIZES the Assignees, the Assignees' successors and assigns, or anyone said Assignees may properly designate, to apply for Letters Patent in the U.S. and any and all foreign countries and regions, in Assignees own name if desired, and additionally to claim priority to the filing date of the Utility Application and otherwise take advantage of the provisions of any international conventions.


