ASSIGNMENT

WHEREAS, PARFUM DE CHANTECAILLE, INC., a New Jersey corporation, with a business address at 584 Broadway, Suite 1111, New York, New York 10012, (“ASSIGNOR”) was the owner by assignment of U.S. Design Patent No. D638,706 for COMBINED CAP AND COLLAR which was issued by the U.S. Patent and Trademark Office on May 31, 2011;

WHEREAS, CHANTECAILLE BEAUTE, INC., a New Jersey corporation, with a business address at 584 Broadway, Suite 1111, New York, New York 10012 (hereafter “CBI”) has, as of March 31, 2012, succeeded to the business and assets of ASSIGNOR, PARFUM DE CHANTECAILLE, INC.;

WHEREAS, ASSIGNOR, PARFUM DE CHANTECAILLE, INC., did, as of March 31, 2012, assign and transfer ownership of all of its rights, titles and interests in and to U.S. Design Patent No. D638,706 for COMBINED BOTTLE AND COLLAR and the design set forth therein in the United States and its territories and possessions and any rights in foreign countries or jurisdictions on a worldwide basis relating thereto to CBI and its successors and assigns;

AND, WHEREAS, the parties desire to formalize and affirm the said Assignment and to record same in the U.S. Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the ASSIGNOR, PARFUM DE CHANTECAILLE, INC., hereby ratifies and affirms the said assignment and transfer of ownership to CBI, and the successors and assigns of CBI, of all of its rights, titles and interests in the United States and its territories and possessions and any rights which may exist in any foreign countries or jurisdictions on a worldwide basis, including the right to claim priority, including any and all improvements disclosed therein, and in and to all Design Patent rights to be obtained for said design by the above Design Patent, or any continuation, continuation-in-part, divisional, renewal, or substitute thereof, and any reissue or reexamination or other post issuance proceedings thereof.

ASSIGNOR hereby covenants that no assignment, sale, agreement, or encumbrance has been, or will be, made or entered into which would conflict with this Assignment.


ASSIGNOR authorizes ASSIGNEE to make applications for, and to receive, Design Patent rights for said design in the United States and any of its territories and possessions or in any foreign countries or jurisdictions on a worldwide basis in CBI's name.

ASSIGNOR covenants and agrees to execute or procure any further necessary assurance of the title to said design, and any Design Patent rights which may issue therefor in the United States and any of its territories and possessions or any foreign country or jurisdiction on a worldwide basis, and to, at any time, upon the request and at the expense of CBI, deliver any testimony in any interference, derivation proceeding, litigation, or proceeding related thereto, and to execute all papers that may be necessary or desirable to perfect the title to said design, or any Design Patent rights which may be granted therefor in the United States and any of its territories and possessions or any foreign countries or jurisdictions on a worldwide basis in CBI, its successors and assigns, and to, at any time, upon the request and at the expense of CBI, execute any continuation, continuation-in-part, divisional, renewal, or substitute thereof, any reissue or reexamination or other post issuance proceedings thereof, or any other additional applications for Design Patent rights for said design in the United States and any of its territories and possessions, or any foreign countries or jurisdictions on a worldwide basis, all of which applications and any Design Patent rights issuing thereon are hereby assigned to CBI, will make all rightful oaths or declarations, and do all lawful acts requisite for procuring the same therein, without further compensation, but at the expense of CBI, its successors and assigns.

ASSIGNOR authorizes and requests the U.S. Commissioner of Patents to record CHANTECAILLE BEAUTE, INC. as the ASSIGNEE and record owner of the aforementioned Design Patent No. D638,706.
