Release of Second Lien Patent Security Agreement

This Release of Second Lien Patent Security Agreement, dated as of **December 1, 2021** (the "Release"), is made by **ARES CAPITAL CORPORATION**, as collateral agent for the Second Lien Secured Parties (in such capacity, the "Agent") in favor of **UNITE MERGER SUB CORP.**, a Delaware corporation, and **THE ULTIMATE SOFTWARE GROUP, INC.**, a Delaware corporation (each, a "Grantor" and collectively, "Grantors").

WHEREAS, by (i) that certain Second Lien Security Agreement, dated as of May 3, 2019 in favor of Agent (as amended, restated, or modified from time to time, the "Security Agreement") and (ii) that certain related Second Lien Patent Security Agreement, dated as of **May 3, 2019** in favor of Agent (as amended, restated, or modified from time to time, the "Patent Security Agreement"; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Patent Security Agreement, as applicable), Grantors granted to Agent, for the benefit of the Second Lien Secured Parties, a security interest in and continuing lien on all of each Grantor's right, title and interest in and to the Collateral (as defined in the Patent Security Agreement), including those Patents listed on Schedule I hereto;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on May 6, 2019 at Reel 049087 Frame 0349;

WHEREAS, Grantors desire Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral of each Grantor, including, without limitation, the Patents set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Second Lien Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral of each Grantor and assigns, transfers and conveys to such Grantor any and all of its rights, title and interests in the Collateral.

Agent authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
