Further, we agree that we will communicate to WizRocket Inc., or its representatives, any facts known to us respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all subsequent, related provisional, U.S. non-provisional, divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to WizRocket Inc. make all rightful oaths, and generally do everything possible to aid WizRocket Inc., and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
