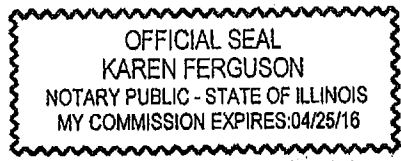
I further covenant and agree to promptly communicate to said assignee or its representatives any facts known to me relating to said invention, to testify in any interference

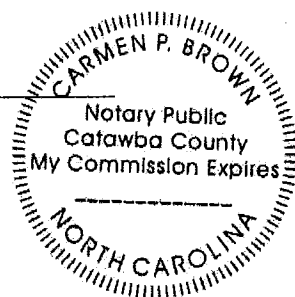
