ASSIGNMENT

This Assignment, made by and between AbbVie Inc., a company organized and existing under the laws of the State of Delaware and having a business address at 1 North Waukegan Road, North Chicago, IL 60064, U.S.A. (“Assignor”), and Calico Life Sciences LLC, a Limited Liability Company, having its principal place of business at 1170 Veterans Blvd, South San Francisco, California 94080, U.S.A. (“Assignee”);

WHEREAS, Assignor owns the entire right, title and interest of Marina Pliushchev, Jennifer M. Frost, Lawrence A. Black, Xiangdong Xu, Ramzi Farah Sweis, Lei Shi, Qingwei I. Zhang, Yunsong Tong, Charles W. Hutchins, Seungwon Chung, and Michael J. Dart in and to United States Patent Application No. 16/098,946, filed on November 5, 2018, and entitled, **MODULATORS OF THE INTEGRATED STRESS PATHWAY** (and identified by Attorney Docket No. CLS-001) (the “Patent Rights”) and the invention(s) described and/or claimed in the Patent Rights (the “Inventions”); and

WHEREAS, Assignee desires to acquire an undivided 50% interest in and to the Inventions and Patent Rights identified above, and Assignor desires to assign an undivided 50% interest to Assignee, as set forth below;

NOW, THEREFORE, in exchange for valuable and legally sufficient consideration, the receipt of which is hereby acknowledged:

1. The Assignor have sold, conveyed, assigned and transferred, and by these presents do sell, convey, assign and transfer, to the Assignee an undivided 50% interest in Assignor’s entire right, title and interest for the United States and all other jurisdictions in and to the Inventions and Patent Rights identified above, and any patents that may issue for said Inventions, together with all patent applications, patents, utility models and designs therefore, including without limitation all continuations, divisions, renewals, revivals, reissues, reexaminations, extensions, supplementary protection certificates, and any substitute applications thereof, including an undivided 50% interest in the full right to claim all benefits and priority rights thereto under any applicable convention or treaty including without limitation the Paris Convention, and an undivided 50% interest in all rights of action arising from the foregoing, including without limitation all claims for damages by reason of present, past and future

infringement or violation of the foregoing and all present, past and future rights to sue and collect damages or seek injunctive relief for any such infringement or violation of the foregoing, in each case, to have and to hold for sole and exclusive use and benefit of the Assignee, its successors and assigns. Assignor hereby acknowledges that this Assignment, being of an undivided 50% interest in Assignor's entire right, title and interest in and to the Inventions and the Patent Rights carries with it the right in Assignee to apply for and obtain from competent authorities in all countries of the world any and all patents by attorneys and agents of Assignee's selection and the right to procure the grant of all patents to Assignee in its own name as assignee of Assignor's entire right, title and interest therein.

2. The Assignor hereby covenant and agree that Assignor have the full right to convey the interests granted by this Assignment; and that the Assignor will assist the Assignee (including prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance all to the extent deemed necessary or desirable by Assignee to secure an undivided 50% interest in the Patent Rights and Inventions to Assignee) in the prosecution of the patent applications identified above, in the making and prosecution of any other applications that the Assignee may elect to make covering the inventions identified above, in vesting in the Assignee with an undivided 50% interest in such other patent applications and patents, in the prosecution of any interference which may arise involving said Inventions, or any such patent application or patent, and in assisting Assignee in the defense and enforcement of any rights arising out of such patent application or patent, or this Assignment; and that the Assignor will execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.

3. The terms and covenants of this Assignment shall inure to the benefit of said Assignee, its successors, assigns and other legal representatives, and shall be binding upon the Assignor, its successors, assigns and other legal representatives.
