RELEASE OF SECURITY INTEREST  
IN PATENTS

This RELEASE OF SECURITY INTEREST (this “**Release**”), dated as of November 4, 2021, is made by Golub Capital LLC, as Administrative Agent (“**Administrative Agent**”) from time to time a party to the Credit Agreement (as defined below).

WHEREAS, pursuant to that certain Credit Agreement, dated as of November 14, 2017, by and among Nexus Brands Group, Inc. (“**Nexus Borrower**”), G&G Distribution, Inc. (“**G&G Borrower**” and, together with Nexus Borrower, the “**US Borrowers**”), Blade Acquisition Limited (the “**Blade Borrower**”), Setter Acquisition Limited (“**Seacoya Borrower**” and, together with Blade Borrower, the “**UK Borrowers**” and, collectively with the US Borrowers, the “**Borrowers**”), NBG Intermediate Holding Corp. (“**Holdings**”), NBG-P Intermediate Holding Corp. (“**G&G Holdings**” and, together with Holdings, the “**Holding Companies**”), the other Credit Parties from time to time party thereto, Golub Capital LLC, as the Administrative Agent, the Revolver Agent, and the L/C Issuer and the Lenders from time to time party thereto (as amended by (i) that certain First Amendment to Credit Agreement, dated as of March 12, 2018, (ii) that certain Second Amendment to Credit Agreement, dated as of December 5, 2018, (iii) that certain Third Amendment to Credit Agreement, dated as of March 8, 2019, (iv) that certain Fourth Amendment and Waiver to Credit Agreement, dated as of December 23, 2019, (v) that certain Fifth Amendment to Credit Agreement, dated as of February 27, 2020, (vi) that certain Sixth Amendment to Credit Agreement, dated as of November 5, 2020, (vii) that certain Seventh Amendment to Credit Agreement, dated as of May 28, 2021 and (viii) that certain Consent and Eighth Amendment to Credit Agreement, dated as of October 14, 2021 (as may be further amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “**Credit Agreement**”)).

WHEREAS, the Borrowers, the entities set forth on Schedule 1 hereto (together, the “**Grantors**” and each, a “**Grantor**”) and the other parties thereto are party to a Guaranty and Security Agreement dated of even date with the Credit Agreement (as amended, restated, amended and restated, supplemented, waived or otherwise modified from time to time, the “**Security Agreement**”) in favor of the Administrative Agent.

WHEREAS, pursuant to the Security Agreement, the Grantors executed in favor of Administrative Agent the applicable Patent Security Agreement set forth on Schedule 2 hereto (each, a “**Patent Security Agreement**”), each of which was recorded at the United States Patent and Trademark Office on the date and at the Reel/Frame specified in Schedule 2 hereto, wherein each Grantor granted to Administrative Agent a security interest in all of such Grantor’s rights, title and interest in and to the Patent Collateral (as defined in the applicable Patent Security Agreement), including without limitation the intellectual property set forth on Schedule 3, Schedule 4, Schedule 5, Schedule 6 and Schedule 7 attached hereto (collectively, the “**Collateral**”);

WHEREAS, each Patent Security Agreement was recorded in the United States Patent and Trademark Office on the date and at the Reel/Frame specified in Schedule 2 hereto;

WHEREAS, Administrative Agent has agreed to terminate and release its security interest in all such Collateral, as provided in each Patent Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby relinquishes, terminates, cancels and releases any and all right, title and interest it may have or have acquired in the Collateral through each Patent Security Agreement, including all rights of any kind whatsoever of each Grantor accruing under the Collateral provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world; any and all patents, trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered,

including the patent registrations and applications set forth on Schedule 3, Schedule 4, Schedule 5, Schedule 6 and Schedule 7 hereto, together with all extensions and renewals thereof and amendments thereto; any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages. Administrative Agent hereby authorizes and requests that this Release be recorded at the United States Patent and Trademark Office, or any other applicable location. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in each Patent Security Agreement, and if not set forth therein, the Credit Agreement.
