PATENT ASSIGNMENT AGREEMENT

This Patent Assignment Agreement (this “**Patent Assignment**”), is made as of November 29, 2021, by and among Organicix, LLC (d/b/a DaVinci Tech), a Nevada limited liability company located at 6770 Paradise Road, Las Vegas, Nevada 89119 (“**DaVinci**”), Asian ProSource, LLC, a Nevada limited liability company located at 6770 Paradise Road, Las Vegas, Nevada 89119 (“**ProSource**”), East-West Bridge, Inc., a Nevada corporation (“**East-West**”), and, Cortney Smith an individual, domiciled at 1561 Sabatini Drive, Henderson, Nevada 89052 (“**C. Smith**,” and collectively with DaVinci, ProSource, and East-West, “**Seller**”), and Warehouse Goods LLC, a Delaware limited liability company located at 1095 Broken Sound Pkwy NW Ste 300, Boca Raton, Florida 33487 (“**Buyer**”), the purchaser of certain assets of Seller.

WHEREAS, Seller and Buyer are parties to a certain Asset Purchase Agreement, dated as of October 13, 2021 (the “**Asset Purchase Agreement**”) by and among Seller, Buyer and the other parties named therein; and

WHEREAS, under the terms of the Asset Purchase Agreement, Seller has agreed to convey, transfer, and assign to Buyer, among other assets, certain intellectual property of Seller, and has agreed to execute and deliver this Patent Assignment, for recording with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions.

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby irrevocably sells, conveys, assigns, transfers and delivers to Buyer all of Seller’s right, title and interest of every nature and kind in and to the following:

(a) the patents and patent applications set forth on Schedule 1 hereto and any and all continuations, continuations-in-part, divisionals, reissues, reexaminations, renewals, substitutes, and patent(s) that may be granted thereof (the “**Assigned Patents**”), together with any and all inventions disclosed in the Assigned Patents, all rights to claim priority to and from the Assigned Patents, all applications for patent that have been filed and may be filed in the United States or any foreign country that claim priority to the Assigned Patents, all patents that may be granted on the Assigned Patents in the United States or any foreign country, and all extensions, renewals and reissues thereof;

(b) all rights of any kind whatsoever of Seller accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(c) any and all royalties, fees, income, payments, and other proceeds hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, violation, misuse, breach, or default, with the right, but no obligation, to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Seller hereby authorizes the officials of the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any other applicable jurisdictions set forth in Schedule 1, to record and register this Patent Assignment upon request by Buyer. Following the date hereof, Seller will take such steps and actions, and provide such cooperation and assistance to Buyer and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned Patents to Buyer, or any assignee or successor thereto.

3. Terms of the Asset Purchase Agreement. The parties hereto acknowledge and agree that this Patent Assignment is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Seller and Buyer with respect to the Assigned Patents. The representations, warranties, covenants, agreements, and indemnities contained in the Asset Purchase Agreement will not be superseded hereby but will remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement will govern.

4. Counterparts. This Patent Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together will be deemed one and the same agreement. A signed copy of this Patent Assignment delivered by facsimile, e-mail, or other means of electronic transmission will be deemed to have the same legal effect as delivery of an original signed copy of this Patent Assignment.

5. Successors and Assigns. This Patent Assignment will be binding upon and will inure to the benefit of the parties hereto and their respective successors and assigns.

6. Governing Law. All questions concerning the construction, validity and interpretation of this Patent Assignment will be governed by and construed in accordance with the domestic laws of the State of Florida, without giving effect to any choice of law or conflict of law provision (whether of the State of Florida or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Florida.


