Assignors hereby request that said Patents be issued in accordance with this Assignment.

Assignors further covenant and agree that, at the time of the execution and delivery of these presents, Assignors possess the unencumbered right and authority to make this Assignment.

Assignors further covenant and agree, and likewise bind their heirs, legal representatives and assigns, to promptly communicate to said Assignee or its representatives any facts known to them relating to the Invention, to testify and/or assist as requested by the Assignee in any interference or legal proceedings involving the Applications, Patents, or Invention, including cooperating in any enforcement proceedings involving the Applications, Patents, or Invention, to execute any additional papers which may be requested to confirm the right of the Assignee, its representatives, successors and assigns to secure patent or similar protection for the Invention in all countries and to vest in the Assignee complete title to the Invention and Patents, without further compensation, but at the expense of said Assignee, its successors, assigns and other legal representatives.
