NUNC PRO TUNC PATENT ASSIGNMENT AGREEMENT

This *nunc pro tunc* patent assignment agreement is effective as of January 1, 2017, by and between Veeco ALD Inc. ("VALD"; "Assignor"), a company incorporated in the State of Delaware, and Veeco Instruments Inc. ("Veeco"; "Assignee"), a company incorporated in the State of Delaware.

WHEREAS, VALD is the owner of the entire right, title and interest in and to the patents and patent applications, and the inventions disclosed in the following (hereinafter referred to collectively as the **Patent Rights**):

WHEREAS, Veeco is desirous of obtaining all right, title and interest in and to the **Patent Rights**; and

WHEREAS, VALD is agreeable to assigning the **Patent Rights** to Veeco.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the said VALD has sold, assigned, transferred and set over, and by these presents does hereby sell, assign, transfer and set over, unto the said Veeco, its successors, legal representatives and assigns as of the effective date recited above, all right, title and interest in, to and under the **Patent Rights**, including specifically the right to claim priority from said **Patent Rights** as fully and entirely as the same would have been held and enjoyed by VALD if this assignment and sale had not been made, together with all claims for damages by reason of past infringement of the **Patent Rights** with the right to sue for and collect the same for Veeco's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.

VALD agrees to execute upon the request of Veeco any assignment paper or other document reasonably necessary to evidence the assignment of the rights hereunder to Veeco, and agrees to cooperate with Veeco in all other matters relating to the assignment of these rights to Veeco.


This Agreement shall be construed in accordance with and governed by the laws of the State of Delaware, excluding any choice of law rules which direct the application of the laws of another jurisdiction.

This assignment may be executed in any number of counterparts, each of which will be deemed an original, but all of which together constitute one and the same instrument. Executed signature pages to this assignment may be delivered by facsimile, or by email in portable document format (.pdf) and delivery of the signature page by such method will have the same effect as if the original signature had been delivered by the sending party to the receiving party.






