## CONFIRMATORY ASSIGNMENT OF PATENT RIGHTS AND DESIGN RIGHTS

THIS DEED is dated the 16<sup>th</sup> day of December 2021

### PARTIES

- (1) **NEW TERRITORY DESIGN LIMITED**, a company duly organised and existing under the laws of England and Wales, whose registered office is at 42 Gloucester Way, London, United Kingdom, EC1R 0BR, registered under the number 10704986 ("**Assignor**"); and
- (2) **UNIVERSAL MOVEMENT LTD**, a company duly organised and existing under the laws of England and Wales, whose registered office is at 42 Gloucester Way, London, United Kingdom, EC1R 0BR, registered under the number 12283615 ("**Assignee**"),

(together, the "**Parties**".)

### RECITALS

- (A) Assignor is the applicant for and/or registered proprietor of the patent rights listed in Schedule 1 (the "**Patent Rights**"), which disclose various inventions (the "**Inventions**"), and is the applicant for and/or registered proprietor of the registered design rights listed in Schedule 2 (the "**Design Rights**").
- (B) The Parties have signed on May 15, 2020 an Assignment of Intellectual Property Rights (the "**IPR Assignment Agreement**") assigning certain intellectual property rights to Assignee.
- (C) To evidence and confirm the assignment of the Patent Rights and Design Rights from the Assignor to the Assignee pursuant to the IPR Assignment Agreement, the parties desire to enter into this Confirmatory Assignment on the terms herein.


### OPERATIVE PROVISIONS


1. In consideration of the premises and for further valuable consideration the receipt and sufficiency of which the Assignor hereby acknowledges, Assignor hereby irrevocably assigns, conveys and transfers by deed to Assignee all such right, title and interest as they may have in:
  - (a) the Patent Rights, the Inventions and the Design Rights;
  - (b) all rights subsisting in, relating to or attaching to the Patent Rights, the Inventions and the Design Rights including all unregistered design rights, copyright, confidential information and any other similar rights;
  - (c) all rights to seek protection for the Inventions and Design Rights (whether by way of patents, utility models, registered designs or otherwise) in all countries including the right to claim priority from the Patent Rights and Design Rights or any of them; and
  - (d) the right to bring legal proceedings to secure damages and any other appropriate remedies in respect of any infringement of any of the aforesaid rights which may have occurred prior to the date of this Assignment.
2. This Assignment and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and

construed in accordance with the law of England and Wales and the Parties hereby irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to hear and determine any such dispute or claim.
