AND, ASSIGNOR HEREBY assigns unto Assignee all equitable and legal claims for damages by reason of infringement prior to, at or after the assignment date of the Assigned Patents throughout the world, with the right to sue for and collect and retain both such past, present and future damages for its own use and benefit, and for the use and benefit of its successors, assigns, and other legal representatives.

AND, ASSIGNOR HEREBY covenants that it has the full right to convey the interest assigned by this Assignment, and that Assignor has not executed and will not execute any agreement in conflict with this Assignment;

AND, ASSIGNOR HEREBY further covenants and agrees that it will, without further consideration, communicate with Assignee, its successors and assigns, any facts known to it respecting the Assigned Patents, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title of the Assigned Patents in the Assignee, its successors or assigns, execute all non-provisional, divisional, continuation, continuation-in-part and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee, its successors and assigns, to obtain and enforce proper patent protection for the Assigned Patents in the United States and any foreign country, it being

understood that any expense incident to the execution of such papers shall be borne by Assignee,


