or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of intellectual property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for said inventions in any country or countries foreign to the United States of America and all extensions, renewals and reissues thereof.

Assignor authorizes and requests the Commissioner for Patents to record Assignee as the owner of the Patent Application, including any continuations, divisions, continuations-in-part, reissues, reexaminations or extensions thereof, and to issue any and all letters patents of the United States thereon to Assignee, as assignee of the entire right, title and interest in and to the same, for the sole use and enjoyment of Assignee, its heirs, successors, assigns or other legal representatives.

Assignor hereby represents and warrants that Assignor's right, title and interest in and to the Patent Application is free and clear of any liens or encumbrances, that Assignor has the full right to assign all of Assignor's interest therein, and that Assignor has not executed and will not execute any agreement or other instrument in conflict herewith.




