This Nunc Pro Tunc Patent Assignment Agreement is made this 6 day of January 2022, and effective as of May 29, 2007, by and between Paul B. Sides ("Sides"), individually, and SSI Investments I, Ltd., a Texas limited partnership conducting business under the assumed name of Texas Hunter Products ("SSI d/b/a Texas Hunter Products").





NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Sides agrees that Sides hereby assigned unto SSI d/b/a Texas Hunter Products nunc pro tunc effective as of May 29, 2007, all right, title and interest in and to the Assigned Patent, and the invention disclosed therein, all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals thereof, and other rights to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur.
