

AND we hereby covenant for ourselves and our legal representatives, and agree with said ASSIGNEE, their successors and assigns, that we have granted no right or license to

make, use, sell or offer to sell said improvements, to anyone except said ASSIGNEE, that prior to the execution of this deed, our right, title and interest in said improvements had not been otherwise encumbered, and that we have not and will not execute any instrument in conflict therewith;

AND we do hereby authorize and request the Director of the United States Patent and Trademark Office or the Patent Office of any country foreign thereto to issue any and all letters patent which may be granted upon said applications, including any patent of any country which have been or may be granted on any of the aforesaid applications, or upon said improvements or any parts thereof when granted, to said ASSIGNEE.


