RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL, dated as of December 31, 2021 (this “Release”), is made by JPMORGAN CHASE BANK, N.A., as administrative agent (in such capacity, the “Agent”), in favor of Resideo Life Care Solutions LLC, a Delaware limited liability company (f/k/a Honeywell HomMed LLC), (the “Grantor”), as follows. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Amended and Restated Collateral Agreement dated as of February 12, 2021 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”) and the Patent Security Agreement (as defined below), as applicable.

WITNESSETH

WHEREAS, pursuant to the Collateral Agreement, Grantor and Agent entered into that certain Patent Security Agreement (as defined below), dated as of October 25, 2018, and recorded with the U.S. Patent and Trademark Office on October 26, 2018 at Reel/Frame No. 047326/0801 (the “Patent Security Agreement”);

WHEREAS, pursuant to the Patent Security Agreement, Grantor granted to the Agent a security interest in and continuing lien on all of Grantor’s right, title and interest in, to and under the patents and patent registrations, including, without limitation, the United States patents set forth on Schedule 1 attached hereto (the “Released Registered Patents”); and

WHEREAS, the Grantor has requested that the Agent release its security interest in and continuing lien on all right, title and interest of the Grantor, including the Released Registered Patents; and

WHEREAS, the Agent now desires to terminate and release its security interest in and continuing lien on all right, title and interest of the Grantor, including the Released Registered Patents and reassign any all rights, title and interest in the same to the Grantor.


