Vorso Corp., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the “**Corporation**”), hereby certifies as follows:

1. The name of the Corporation is Vorso Corp. The Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on September 28, 2017.

2. The Article I of the Amended and Restated Certificate of Incorporation, as amended, of the Corporation (the “**Charter**”) is hereby amended and restated to read in its entirety as follows:

3. Article V, Section 1(c) of the Charter is hereby amended and restated to read in its entirety as follows:

This Certificate of Amendment to the Corporation’s Amended and Restated Certificate of Incorporation has been duly authorized and adopted by the Corporation’s Board of Directors in accordance with the provisions of Section 242 of the Delaware General Corporation Law, and has been duly approved by the written consent of the stockholders of the Corporation in accordance with Section 228 of the Delaware General Corporation Law.
