



- c. Assignor hereby further assigns to Assignee all of its right to (i) all damages and other proceeds hereafter recovered or received in any infringement suit, settlement or other proceeding related to the Patents, (ii) the right to sue for past, present, and future infringement of the Patents, and (iii) all other rights corresponding to the Patents, including but not limited to, all license agreements covering any patents and any existing or future applications and registrations related to the Patents throughout the world.
