We are pleased to inform that the legal entity Kongsberg Maritime CM AS (“**KMCM**”) has now been successfully merged with its parent company Kongsberg Maritime AS (“**Kongsberg Maritime**”). Please find attached a verified and notarized confirmation from the official Norwegian Register of Business Enterprises stating that the merger was completed on 7 January 2021.

The completion of the merger has the following effects pursuant to the Norwegian Corporations Act of 1997, Section 13-16:
